1. OBJECTIVE

Guide the process of anti-money laundering and combating the financing of terrorism in the Petrobras Group, including how to detect, analyze and report potentially suspicious situations and atypical operations.

2. APPLICATION AND SCOPE

Petrobras, to be deployed to the other Companies in the Petrobras Group, respecting their due corporate procedures, as set forth in Petrobras' Bylaws.

6. DESCRIPTION

3.1. General Provisions

Money laundering can be set up in any financial transaction that generates an asset or a value that is a result of an illegal act. Its purpose is to allow the money resulting from an illegal activity to be used legally. In this regard, it assumes an antecedent crime, such as fraud, corruption, terrorism, drug and/or human trafficking, tax evasion, stielionate, counterfeiting and piracy. No company is immune from the risk of being misused by criminal organizations in money laundering situations, thereby jeopardizing their image and reputation and enabling a host of other penalties.

On the other hand, the financing of terrorism involves obtaining funds for financing terrorist activities. While the concepts of money laundering and the financing of terrorism differ in many ways, they are closely linked, as these crimes often exploit the same vulnerabilities that allow for an inadequate level of anonymity and lack of transparency in the conduct of operations. Some countries and international agencies, as part of their external policies, manage lists of sanctions (e.g., embargoes) on countries, entities and individuals suspected of engaging in activities such as terrorism.

Therefore, Petrobras is committed to minimizing the risk of money laundering and the financing of terrorism in its operations. To this end, the Company requires its employees, as well as its subsidiaries, to comply with policies and standards, which aim to prevent their involvement in activities that may be related to these illegal acts. In this way, the Petrobras Group commits to maintain controls and periodically review its strategies and guidelines, in accordance with the best practices related to its sector of activity.

In addition, the presence of subsidiaries incorporated in other countries, transactions executed with foreign institutions, such as financing, or the fact that the company is a party to international agreements and pacts, may imply the need for the Petrobras Group to present procedures adhering to the rules and legislation of those territories to prevent money laundering and terrorism financing.

In this regard, the Petrobras Group must observe all applicable lists of economic sanctions (e.g., embargoes). The duty to comply with these sanctions may result from commitments entered into in financing contracts. Therefore, it is the responsibility of the Organizational Units and Petrobras Group companies to implement and execute specific controls in order to mitigate the risk of violation of these lists of sanctions (e.g., embargoes).

However, it should be noted that these lists of economic sanctions (e.g., embargoes) should not be mistaken for the lists administered by Ministério da Transparência, Fiscalização e Controladoria-Geral da União (CEIS and CNEP), or the list of sanctioned suppliers by Petrobras.

In order to advise the Organizational Units and the companies of the Petrobras Group to mitigate the risk of violation of these lists, the area responsible for compliance activity in Petrobras consolidates them monthly in a single document called the Lista de Sanções Comerciais and makes it available on the [PLDFT](#) intranet page, through a Monthly DIP, and through BW. To request an access profile and to carry out consultations of the Lista de Sanções Comerciais through BW, we suggest reading the Passo a Passo para Consulta (Annex I).

This standard must be used to facilitate an understanding of the theme throughout the entire Work Force. For the proper identification of processes subject to the risk of money laundering and the financing of terrorism, analysis of the level of exposure, evaluation of controls and evaluation of the need for treatment and monitoring, it is necessary that all managers of processes and macro processes follow the guidelines established in PP-1PBR-00163, which deals with the corporate risk management methodology regarding fraud, corruption and money laundering.

3.2. Anti-Money Laundering and Combating the Financing of Terrorism Process

The Anti-Money Laundering and Combating the Financing of Terrorism (PLDFT, for its initials in Portuguese) process is composed of a set of organized and integrated actions:

- Standardization and Guidance
- Know your Counterparties
- Know your Employees
- Fraud, Corruption and Money Laundering Risk Management
- Suspicious Operations Communication
- Continuous Transactions Monitoring
- Reporting

3.2.1. Standardization and Guidance

The corporate guidelines for the PLDFT process are described in the Compliance Policy, PPC, PP-1PBR-00163, [PLDFT](#) intranet page and in this standard.

3.2.2. Know your Counterparties

The selection of suppliers, partners, customers, and other counterparties should take into consideration reputations, ethical conduct, and practices related to fraud prevention and corruption, as well as verification of accounting, economic, financial, tax, legal, environmental and Counterparty locational aspects, when applicable.

In order to achieve this, the Integrity Due Diligence (DDI, for its initials in Portuguese) of counterparties and members of their respective corporate staff is essential.

3.2.3. Know your Employees

A previous Integrity Background Check (BCI, for its initials in Portuguese) should be performed in all Petrobras nominations for managerial positions, at all hierarchical levels, including officers and directors in other companies in which it has a stake, as well as associations, foundations and representative entities in general.

3.2.4. Fraud, Corruption and Money Laundering Risk Management

Some processes are more exposed than others to the risk of money laundering and/or the financing of terrorism, and the following are more vulnerable to these risks:

- Procurement of consulting services, advice, or assistance.
- Sale or acquisition of assets or equity interest.
- Granting of credit to customers and suppliers.
- International trading operations.
- Foreign exchange operations.
- Transactions with related parties.
- Sponsorship, charitable contributions and agreements with Non-Governmental Organizations (NGOs).
- Offshore payments.
- Chartering of vessels.
- Payments made manually in the system.
- Assignment of credit rights to Factoring companies.

- Procurement of advertising agencies.
- Procurement of insurance.

It is the responsibility of the managers of these processes to manage fraud, corruption and money laundering risks and implement the necessary measures for reducing exposure to tolerable levels, as the area responsible for compliance in the company is responsible for guiding and evaluating risk management actions.

In this regard, before initiating a transaction with any counterparty, process managers exposed to the risk of money laundering and/or terrorist financing should consult the Lista de Sanções Comerciais, made available on a monthly basis by the area responsible for compliance activity in Petrobras. As described in the Rotina de Consulta (Annex II), if the process manager identifies that the counterparty with whom he intends to transact is sanctioned, he should consult the area responsible for the company's legal activities regarding the applicability of the sanction, prior to the intended transaction, copying the **PLDFT** email.

3.2.5. Suspicious Operations Communication

Organizational Units and the Work Force must report irregularities related to money laundering and the financing of terrorism through the Whistleblower Channel. Should you have any questions or suggestions, access intranet page **PLDFT** or send an email to **PLDFT**.

In the case of the Petrobras Group companies, doubts or suggestions should be sent to the area responsible for the local compliance activity or the compliance focal point. If additional guidance is still needed, local representatives of the compliance activity may contact CONF/CPPC/CESR.

In this context, the following is an example and non-exhaustive list of operations that may represent evidence of money laundering and/or the financing of terrorist activity and therefore must be monitored by the areas where they are carried out:

- Operations involving entity, final beneficiaries, partners, shareholders, attorneys or legal representatives located in jurisdictions deemed to be high risk or with strategic deficiencies in preventing and combating money laundering and the financing of terrorism by the FATF (See <http://www.fatf-gafi.org/countries/#high-risk>);
- Operations involving entity, final beneficiaries, partners, shareholders, attorneys or legal representatives located in jurisdictions deemed to be favored taxation and/or privileged tax regime by the Department of Federal Revenue of Brazil (RFB Normative Instruction 1,037 of June 4, 2010);
- Payments made in countries other than those where the service was provided;

- Credit assignments to third parties not contractually related
- Counterparties or their partners or intermediaries previously involved in money laundering investigations;
- Complex business structures with no apparent business purpose;
- Recurrent contract amendments, especially on dates close to elections;
- Apparently fictitious operation or with indications of overbilling or sub-billing;
- Sale or acquisition of overvalued or undervalued assets or equity interests;
- Requests for transfers of money or return of deposits to a third party or an account not known;
- Split payments related to the same contract;
- Representation of different entities by the same attorneys or legal representatives, without reasonable justification
- Carrying out contracting operations with the use of intermediates;
- Commission disproportionate to the services provided;
- Use of the same commercial address by different entities, without reasonable justification;
- Execution of any business in a different way from the formal procedure adopted by the Company;
- Recurring changes of corporate object or name in the counterparties Articles of Association or Bylaws;
- Purchases and advances of payments without linked request;
- Exceptionally favorable conditions;
- Change of bank data without reasonable justification;
- Request for payment in cash, check or in currency that is different from the one agreed in contract.

3.2.6. Continuous Monitoring of Transactions

Petrobras Group must adopt rules and procedures for the continuous monitoring of transactions and operations carried out that allow the identification of situations that

may indicate materialization of the risks of fraud, corruption and money laundering.

3.2.7. Reporting

Petrobras Group exposure to the risk of money laundering and the financing of terrorism must be periodically reported to the top management, either directly or through technical bodies responsible for advising officers and directors.

3.3. Authority and Responsibility

3.4. Common Corporate Rules

It is recommended that all Petrobras Group companies fully adopt item 3.2 of this standard, as well as adapt item 3.3 to existing structures in each of the companies.

The responsibility for conducting any of the activities described, if there is no specific area to conduct it by some companies, may be of the equivalent area in Petrobras.

International companies are recommended to follow the adaptability guidelines of this standard as per item 3.1.

7. RECORDS

Not applicable.

4. DEFINITIONS

Administrative Accountability Process (PAR, for its initials in Portuguese) - Procedure for the determination of administrative liability of an entity for the performance of harmful acts to the Company, in accordance with Brazilian Anti-Corruption Act 12,846 of August 1, 2013 and Federal Decree 8,420 of March 18, 2015.

Counterparties - refers to suppliers, customers, business partners and sponsored entities.

Countries or places with privileged taxation and privileged tax regimes (popularized under the term "tax havens") – countries or dependencies that do not tax income or tax it at a rate lower than 20% or, furthermore, whose domestic legislation does not allow access to information on the corporate membership of entities or their ownership (RFB Normative Instruction 1,037 of June 4, 2010).

Degree of Integrity Risk (GRI, for its initials in Portuguese) – degree of risk to integrity to which Petrobras may be exposed during the relationship with a counterparty.

Whistleblower Channel – independent, confidential and impartial tool available to external and internal stakeholders of Petrobras and other companies in the Petrobras Group.

European External Action Service (EEAS) – European Union's diplomatic department responsible for assisting the High Representative of the Union for Foreign Affairs and Security Policy in the implementation of the European Union common foreign and security policy.

Factoring – financial transaction in which a business sells its accounts receivable to a third party, who buys these accounts receivable at a discount.

Financial Action Task Force (FATF) – intergovernmental body responsible for establishing standards and promoting the effective implementation of legal, regulatory and operational measures to combat money laundering, the financing of terrorism and other threats related to the integrity of the international financial system.

Financing of Terrorism – to offer, receive, obtain, hold, deposit, solicit, invest or otherwise contribute to the acquisition of goods, assets or financial resources, in order to finance, directly or indirectly, the practice of terrorism.

Integrity Background Check (BCI, for its initials in Portuguese) - Consists of a set of public and personal information from free and/or paid sources, as well as from internal systems, in order to provide support in decision making process when hiring professional to assume managerial positions and in the Petrobras nomination process of officers in Companies where it has a stake.

Integrity Due Diligence (DDI, for its initials in Portuguese) - analysis of the GRI to

which Petrobras may be exposed in the relationship with counterparties based on information related to reputation, suitability and transparency in conducting its business practices, with a proportional extension to the risk of fraud, corruption and money laundering.

Money Laundering – concealment or subterfuge of the nature, origin, location, disposition, movement or ownership of goods, rights or values arising directly or indirectly from a criminal offense (Brazilian Anti-Money Laundering Act 9,613 of March 3, 1998).

Office of Financial Sanctions Implementation (OFSI) – United Kingdom intergovernmental body responsible for establishing standards and promoting the effective implementation of legal, regulatory and operational measures for combating money laundering, financing of terrorism and other threats related to the integrity of the international financial system.

Office of Foreign Assets Control (OFAC) – agency of the U.S. Treasury Department responsible for administering and imposing economic and trade sanctions on terrorists, international narcotics traffickers, individuals engaged in activities related to the proliferation of weapons of mass destruction and other threats to American national security, foreign policy, or to the economy. OFAC publishes the SDN list (Specially Designated Nationals), which lists the persons and companies involved in the crimes described.

Petrobras Program to Prevent Corruption (PPPC) – Petrobras compliance program, consisting of a set of initiatives designed and implemented in a systemic manner, with the approval of the Company's top management, which aims to prevent, detect and correct the occurrence of ethical deviations, including fraud, corruption and money laundering.

Security Council – part of the United Nations organization charged with maintaining international peace and security.

Related Parties – entities or persons with whom a company has the possibility of contracting with, under conditions other than those of independence that characterize transactions with third parties outside the organization.

Terrorism – Practice of acts that occur for reasons of xenophobia, discrimination or prejudice of race, color, ethnicity and religion, when committed with the purpose of provoking social or generalized terror, exposing danger to person, property, public peace or public safety.

Work Force – professionals working under the direct coordination of the organization, such as employees, temporary workers, self-employed and outsourced workers, volunteers and others.
